#### **RECOMMENDED SCHOOL NURSE/ASSOCIATE SCHOOL NURSE ROLES:**

The school nurse may, in collaboration with administrators, guidance personnel, nutritional services personnel, health educators and classroom teachers:

- Assist teachers with reference material, educational resources and curriculum planning.
- Provide teachers and students with nursing expertise when health related problems/questions arise.
- Assist agencies to coordinate community-based health education programs.
- Provide students with periodic in-class supplemental instructions and small group/one on one instruction.
  - However, teacher or VT certified health educator must remain to provide classroom management, student assessment and other teacher responsibilities.
- Provide faculty/school personnel with in-service education programs (e.g. drug and alcohol, nutrition, personal safety).
- Provide family/groups/community with education programs (e.g. drug and alcohol, adolescent development, personal safety programs).
- Represent the needs of health education on the district Whole School, Whole Community, Whole Child
  (WSCC) team (NASN, 2017); this team in your school or Local Education Agency may go by many different
  names (see Manual WSCC Section 16).

   Vermont law defines comprehensive health education as "systemic and extensive" educational program and requires this education for K-12 students. School health programs for K-12 students prove to be more effective in changing health behaviors than occasional programs on a single health topic. Vermont Education Quality Standards (EQS) stipulate each Supervisory Union/Supervisory District/Unified District (SU/SD/UD) have a written and delivered curriculum aligned with standards approved by the State Board of Education that enables students to engage annually in rigorous, relevant and comprehensive learning opportunities that allows them to demonstrate proficiency in seven content areas, including health.
