## Appropriate Use of Rabies Postexposure Prophylaxis (rPEP) in Vermont

#### **BACKGROUND**

Reports of animal bites and bat encounters continue to rise as we reach late summer. A thorough risk assessment should always be performed prior to administration of rabies postexposure prophylaxis (rPEP). Unnecessary administration of rPEP can strain hospital and patient resources and crowd emergency department waiting rooms, potentially exposing otherwise healthy patients to a variety of communicable diseases.

#### What does rabies look like in Vermont?

Rabies is a deadly viral disease of the brain that infects mammals. In Vermont, rabies is most commonly found in wild animals such as raccoons, skunks, foxes, bats and woodchucks. Cats, dogs and livestock can also get rabies if they have never been vaccinated. Rabies risk from domestic species that have been vaccinated for rabies in the past is extremely low. So far in 2023, 22 animals – 12 raccoons, six foxes, three skunks, and one cat – have tested positive for rabies across the state.

#### What is considered a rabies exposure?

The virus is primarily spread through the bite of an infected animal. It is also possible for transmission to occur when infected saliva or neurologic tissue contacts a mucous membrane or open wound, such as a scratch from the animal, but this is extremely rare.

People cannot get rabies by petting or handling animals, or from contact with urine, blood, feces, or fomites (such as bowls, beds, or surfaces that may have saliva from potentially rabid animals).

Small mammals or rodents such as rabbits, mice, and chipmunks are not routinely tested for rabies, but in rare circumstances may be submitted for testing with prior approval from the Health Department. These animals are very rarely infected with rabies and are not known to transmit rabies to humans.

#### **REQUESTED ACTIONS**

#### 1. Report animal bites and administration of rPEP.

All domestic animal bites must be reported to the local <u>Town Health Officer</u> or other town official by calling or by faxing a completed <u>Town Health Officer Animal Bite Report Form</u>. Town Health Officers oversee 10-day observation periods for healthy dogs, cats, and ferrets who bite humans. rPEP is unnecessary while animals complete the observation period.

Health care providers must report the administration of rPEP by faxing a completed Rabies



<u>Postexposure Prophylaxis Report Form</u> to the Health Department's Epidemiology Program at 802-951-4061 or securely e-mailing it to <u>AHS.VDHEpiLabRabies@vermont.gov</u>.

#### 2. Administer rPEP when appropriate.

rPEP should be given to a patient when:

- A person is bitten on the head, neck, or face by a raccoon, skunk, fox, or bat, even if the animal is available for testing. rPEP may be discontinued if the animal tests negative for rabies.
- A person is bitten by a wild or domestic animal and the animal is not available for observation or testing, particularly if the bite was unprovoked or the animal was acting strangely. Bites are considered provoked and lower risk for rabies exposure if a person approaches, feeds, pets, handles, or does something that might frighten the animal.
- A bat is found in the same room as a child or a sleeping person, they cannot definitively say that they were not bitten by the bat **and** the bat is not available for testing. rPEP is usually not necessary while awaiting rabies testing for bats.

# 3. Consider delaying rPEP when further diagnostic information will soon be available, based on clinical judgement.

There is no strict timeframe in which rPEP must be started to be effective, but it must be administered before symptoms of rabies develop, which can occur weeks to months after rabies virus exposure. rPEP is more effective at preventing rabies if administration is not significantly delayed after possible rabies exposure.

If the animal that caused the potential rabies exposure is tested at the Health Department Laboratory, rPEP may be delayed until test results are available (about 48 hours after the animal arrives at the Health Department Laboratory).

## 4. Properly administer rPEP based on current ACIP recommendations.

The following reference table was recreated from the ACIP Rabies Vaccine Recommendations.

Patient Vaccination Status	Intervention	Regimen*
	Wound Cleansing	All rPEP should begin with immediate thorough cleansing of all wounds with soap and water. If available, a virucidal agent such as povidone-iodine solution should be used to irrigate the wounds.

Not previously vaccinated	Human Rabies Immunoglobin (HRIG)	Administer 20 IU/kg body weight. If anatomically feasible, the full dose should be infiltrated around and into the wound(s), and any remaining volume should be administered at a site (intramuscular [IM]) distant from vaccine administration. Also, HRIG should not be administered in the same syringe as vaccine. Because HRIG might partially suppress active production of rabies virus antibody, no more than the recommended dose should be administered.
	Vaccine	Human diploid cell vaccine (HDCV) or purified chick embryo cell vaccine (PCECV) 1.0 mL, IM (deltoid area†), 1 each on days 0,§ 3, 7 and 14.¶
Previously vaccinated**	Wound Cleansing	All rPEP should begin with immediate thorough cleansing of all wounds with soap and water. If available, a virucidal agent such as povidone-iodine solution should be used to irrigate the wounds.  HDCV or PCECV 1.0 mL, IM (deltoid area†), 1 each on days
	Vaccine	0 <sup>s</sup> and 3.

- \* These regimens are applicable for persons in all age groups, including children.
- <sup>†</sup> The deltoid area is the only acceptable site of vaccination for adults and older children. For younger children, the outer aspect of the thigh may be used. Vaccine should never be administered in the gluteal area.
- § Day 0 is the day dose 1 of vaccine is administered.
- ¶ For persons with immunosuppression, rabies PEP should be administered using 5 doses of vaccine on days 0, 3, 7, 14, and 28.
- \*\* Any person with a history of pre-exposure vaccination with HDCV, PCECV, or rabies vaccine adsorbed (RVA); prior full series of rPEP with HDCV, PCECV or RVA; or previous vaccination with any other type of rabies vaccine and a documented history of antibody response to the prior vaccination.

<u>Health Update</u>: Provides updated information regarding an incident or situation; unlikely to require immediate action.

<u>Info Service Message:</u> Provides general correspondence from VDH, which is not necessarily considered to be of an emergent nature.
