


### **Monthly Suicide Report**


July 2023

#### Summary of 2023 Suicide Deaths (to date):

- As of the end of April, the rate of suicide deaths is higher than the 3-year average for previous years, but the difference is not statistically significant.
- While Orleans, Rutland and Windham Counties have year-to-date death rates more than double their 3-year average and the statewide rate, these differences are not statistically significant.
- The rate and number of suicide deaths in 15–24-year-olds is nearly double the 3-year average for previous years, but it is not statistically significant.



#### Overall, the number of Vermonters who have died by suicide this year is higher than previous years.




Suicide deaths in 2023 and 3-year averages by month among Vermont residents\*

Please note there is an 8-week lag in reporting suicide death. An 8-week lag minimizes the changes in numbers posted. Suicide deaths through the end of April are included in this report. There are 15 pending death certificates in 2023.




Suicide death rates per 100,000 Vermont residents.


The number of pending death certificates are deaths that have not been assigned a cause of death in Vermont Vital Statistics. Death certificates that are pending are not necessarily suicide deaths. There are 15 pending death certificates in 2023, one month of <sup>4</sup> death is unknown.

#### Summary of 2023 Suicide-Related Emergency Department (ED) Visit Data (to date):

- The average rate of suicide-related visits through June this year is higher compared to previous years (258.7 per 10,000 visits versus the 2020-2022 average of 231.1 per 10,000 visits).
- Suicide-related ED visits have been higher in every month of 2023 except March, when compared to previous years.

#### Overall, suicide-related ED visits are higher this year compared to previous years.



# ED visit rates for suicidal ideation by county of residence, through June.


ED Visit Rates per 10,000 visits



#### Vermont rate = 258.7 per 10,000 visits


## ED visit rates for suicidal ideation and self-directed violence by sex and age group, through June.
