

Health Care Workforce Census Psychoanalysts, 2022



Overview

This Psychoanalyst census is part of the Vermont Department of Health's healthcare provider data program, which is used to monitor and measure the supply of health care providers in Vermont over time. Vermont psychoanalysts are recertified every two years. Data for this report was obtained during the November 2022 recertification period and represents a snapshot of the profession at that time.

Psychoanalysts provide therapeutic services based on understanding the unconscious and how unconscious processes affect the human mind. In Vermont, psychoanalysts are required to have earned a master's degree, along with a specific degree or graduate certificate by an appropriately accredited psychoanalytic institute.

Workforce

- 42 psychoanalysts renewed their licenses during the surveyed period and 42 of these completed the workforce survey for a response rate of 100%.
- Out of the 42 respondents, 21 (50%) indicated they are active practicing psychoanalysts in Vermont.
- Of the 21 respondents reporting a non-active status, 7 (33%) indicated they are planning to start working as a psychoanalyst in Vermont within the next 12 months.
- The remainder of this report is based on the 21 psychoanalysts who reported actively working in Vermont.

Full Time Equivalents (FTEs)


- 21 psychoanalysts provide 8.0 total FTEs.
- 7.6 FTEs, or 95% of total FTEs, are provided by 18 psychoanalysts aged 60 or older.
- 14% (3) of psychoanalysts work 40 or more hours per week at their main site.

Trends in Statewide FTEs

- Psychoanalysts FTEs have remained fairly steady since 2014, from 8.1 in 2014 to 8.0 in 2022.
- From 2020 to 2022, FTEs decreased by 1.3.

Demographics


Gender

- 62% of the psychoanalysts in Vermont (13) are female.
- 38% (8) are male.

Age

• The median age of psychoanalysts is 71.

Race and Ethnicity

Respondents were asked to select their race and could select multiple responses or choose not to answer, therefore numbers may not equal the total number of licensed nursing assistants.

- 91% of psychoanalysts are white and two preferred not to answer the question about race.
- One psychoanalyst is Hispanic, Latino/a, or of Spanish origin, and 17 (85%) are not. Three preferred not to answer or were missing data for ethnicity.

Education and Training

- Master's degrees are required to hold a Vermont license for psychoanalysts. 62% of licensed psychoanalysts in Vermont have a doctoral level degree.
- 10% have Specialist Degree/ Certificate of Advance Graduate degree.
- 24% have PsyD or PsyaD.
- 33% have a PhD.
- 5% have a MD/DO.
- 65% received their schooling in the Northeast.

Other licenses

Some psychoanalysts hold other mental health credentials, including:

- 2 psychologists
- 2 social workers
- 1 psychiatrist
- 1 mental health counselor

Practice Characteristics

Practice Setting

• 100% of psychoanalysts work in independent solo private practices.

Number of sites

- 91% (19) of psychoanalysts practice at a single practice site.
- 10% (2) work at two or more sites.

Access to Care

- 67% (14) of psychoanalysts accept new patients.
- 5% participate in Medicaid, and none accept new Medicaid clients.
- 5% participate in Medicare, and none accept new Medicare clients.

Specialties

• Most psychoanalysts report specializing in psychoanalytic psychology.

Current Experience and Future Plans

- Median years licensed in Vermont is 9.5 years.
- 15% of psychoanalysts have been licensed in Vermont for over 20 years.
- 67% plan to continue working the same number of hours in the future.
- 19% plan to increase their hours.
- 14% plan to reduce their hours.

Key Takeaways

- There are relatively few psychoanalysts actively working in Vermont, with 21 psychoanalysts providing 8.0 full-time equivalents.
- The number of FTEs has remained fairly steady since 2014, from 8.1 to 8.0 in 2022.
- Even though the median age of psychoanalysts is 71 years, 86% of psychoanalysts plan to continue working the same number of hours or increase their hours in the next 12 months.
- The percentage accepting new patients continues to drop. It was 67% in 2022 compared to 88% in 2018.

Appendix

Active Psychoanalyst

A psychoanalyst who reported working in Vermont as a psychoanalyst (regardless of how many hours) is considered active.

Census

The census was taken during the biennial relicensing process which ended on November 30, 2022. The data include all licensed psychoanalysts except for new licensees enrolled less than three months before the renewal date (September – November 2022), as their license was valid until the next renewal date of November 30, 2024. Copy of census questions available upon request.

Full Time Equivalent (FTE)

Full time is defined as 40 or more working hours in Vermont per week, 48 weeks or more per year. Reporting more than 40 hours per week is defined as <u>one</u> FTE regardless of the number of hours over 40 per week worked.

Main Practice, Site, Setting, and Specialty

The main practice, site, setting, or specialty refer to the practice in which the psychoanalyst worked the greatest number of annual hours.

For county maps, colors define quartiles. The lowest 25% of FTE equivalents to population ratio is displayed in the lightest color, the middle 50% in medium, and highest 25% in the darkest color.

Missing data

Unless otherwise noted, missing data are excluded from tables. Thus, totals may vary from table to table. **Population Estimates**

Weekly Hours

Average weekly hours is based on hours and weeks reported, adjusted to a full-time 48-week working year (hours * (weeks/48)). Thus, the average weekly hours for an individual working 40 hours a week for half the year (24 weeks) is 20.
