- **Approval of the Minutes of February 4, 2026, Board Meeting:**

D. Philibert moved to accept the minutes of the February 4, 2026, meeting. R. Ciappenelli seconded the motion. The motion passed; opposed: none; recused: none; abstained: Dr. Ireland.

- **Administrative Updates (D. Herlihy):**

- Members were updated on the progress of the SRPS IT project. There will be a blackout period for licensees from Monday March 9 until Monday March 23. The project is on target to meet the planned date for “go live” the week of March 23, 2026.
- The next Board meeting is Wednesday April 1, and is **In Person** at the Waterbury offices, Red Oak conference room A283.

- **Other Business:**

- **Possible withdrawal of Michigan from the Interstate Medical Licensure Compact (IMLC).** Members were briefed on the possibility that Michigan will withdraw from the IMLC unless legislation is passed by March 28, 2026, to counter a “sunset” provision that was included in the law passed to adopt the Compact. There was discussion of how the Board should deal with the 119 physicians who hold Vermont licenses that were issued using the Compact and with Michigan as the State of Principal License (SPL).

A motion was made by G. Falk to authorize staff to pursue an emergency rule that requires holders of licenses issued using an SPL that then withdraws from the IMLC to redesignate their SPL, if their circumstances make them eligible for a different SPL, within 90 days of the withdrawal of their present SPL. Dr. Tandoh seconded the motion. The motion passed unanimously.

- **Overview of bills of interest to the Board pending in the Vermont General Assembly.**

Dr. Greenberg reported on his testimony provided to the Senate Health and Welfare Committee on S.142. There was an extended discussion of the bill and it was decided that an ad hoc committee would be formed to further consider the bill and make recommendations to the full Board. Dr. Greenberg, R. Ciappenelli, Dr. Eyler, Dr. Tandoh, and Dr. Tortolani volunteered to be on the ad hoc committee.
