- **Board Issues:** Dr. Greenberg noted that FSMB had sent an email asking for members of boards to serve on FSMB committees.
- Administrative Updates (D. Herlihy):
  - Members were updated on the progress of the SRPS IT project. The project is on target to meet the planned date for "go live" in March 2026.
  - D. Herlihy updated the Board on the progress with the Return to Office state mandate that will require most state employees to work on site in a state office or facility at least three days per week after December 1. This transition poses some extra challenges for the Health Department because of the move last year from Burlington to Waterbury and a lack of space to accommodate all the employees assigned to the central office at the Waterbury State Office Complex.
  - The hearing announced for December has been postponed. It will be rescheduled for June. There is another case with pending charges which will also soon be ready to be scheduled for a hearing.

- Board Meeting Schedule for 2026: The draft calendar of meetings of the Board and standing committees for 2026 was presented. The Board and Licensing Committee schedules were approved. The Investigative Committee schedules will be reviewed at their November meetings and finalized in December.
- Process for IMLCC Profile Cases: D. Herlihy advised members on the process to be used for cases involving individuals who are licensed through the IMLCC and who fail to complete the online physician profile. Licensees receive an initial request and at least three follow-up emails asking them to complete the profile before a case is pursued. The cases are comparable to the cases for licensees who fail to maintain valid contact information, which are worked on by staff without Investigative Committee involvement unless the licensee declines to pay the nondisciplinary financial penalty that the Board Rules specify. Members were invited to ask questions and share any concerns. There were none.
- FSMB 2026 Annual Meeting, Baltimore, MD, April 30 May 2, 2026: It was determined that Gail Falk would be put forth by the Board to receive an FSMB Public Member Scholarship to attend. It was further decided that members Dr. Greenberg, R. Ciappenelli, and Dr. Coddaire would attend.
