• Approval of the Minutes of the November 6, 2024, Board Meeting:

D. Philibert moved to accept the minutes of the November 6, 2024, meeting. S. Lorentz seconded the motion. The motion passed; opposed: none; recused: none; abstained: none.

• Administrative Updates (David Herlihy):

• MD Renewal Data

As of August 30, 6,077 MD licensees. As of December 3: 5,132 renewed / 945 lapsed, 15.5% lapse rate Board of Medical Practice December 4, 2024 Page **2** of **6**

> Broken down by source of license (regular process or via IMLCC process): Regular: started with 4,571 / 3,883 renewed, 945 lapsed = 15% lapse rate IMLCC: started with 1,506 / 1,149 renewed, 357 lapsed = 24% lapse rate, however, 59 MDs licensed through IMLCC had submitted a renewal and were only missing a form that is required to renew through the IMLCC.

• Other Business:

• Election of Board Officers for 2025

Dr. King made the report on behalf of the Nominating Committee. The current officers had stated their agreement to serve another term. No other nominations were submitted. Dr. King submitted the slate of officers and moved for the Board to approve them for the 2025 term – Dr. Hildebrant, Chair; Dr. Greenberg, Vice Chair; Dr. Tortolani, Secretary. D. Philibert seconded the motion. The motion passed unanimously.

• FSMB Annual Meeting:

The FSMB Annual Meeting will take place April 24-26, 2025, in Seattle, Washington. After discussion among members it was decided that, in addition to the Chair and Executive Director, Dr. Greenberg and Suzanne Jones would attend, however, Dr. Greenberg must determine if he will be able to travel that week. If both attend, it will require the Board to fund the travel expenses with funds that are limited to professional development. Dr. Tortolani made a motion to allow the Board to use the limited funds for the purpose of Board members to attend the annual FSMB conference. Dr. Tandoh seconded the motion. Motion passed unanimously. It was also decided that Scott Tucker's name would be submitted to FSMB for a Public Member Scholarship.

• Additional Pathways to Licensure for Foreign-Trained Physicians:

The Board discussed at length the Draft Guidance Document from the Advisory Commission on Additional Licensing Models. The Board identified areas of concern that should be addressed in comments. These included: greater emphasis on the importance of accredited residency training to prepare physicians to provide safe, quality care; the need for resources to support evaluation of overseas medical training programs; the inadequacy of any alternative pathway that allows participation by international medical graduates who have not completed medical training that is accredited or found to be substantially similar to ACGME training; concern about wording in the Advisory Document that might lead to over-reliance on FQHCs and rural clinics, which could over burden those parts of the healthcare delivery system; a general lack of emphasis on patient safety concerns in discussions about creation of alternate licensing pathways for IMGs. The Executive Director and Chair were asked to prepare comments for submission through the FSMB by the December 6, 2024 deadline.

• PA Licensure Compact:

The Board was reminded that during the past session, they had opposed passage of H.572, a bill that proposed to have Vermont join the Physician Assistant Licensure Compact. The Board was informed that a legislator had contacted Board staff to ask if the Board had changed their position, prompting this additional look at the PA Compact. D.Herlihy gave a brief overview of the PA Compact bill and identified some concerns about the structure of the PA Compact.

- The PA compact allows PAs who have significant discipline to obtain a
 privilege to practice in participating states with no opportunity for a
 participating state to evaluate the prior misconduct; two years after
 sanctions are complete no discipline other than revocation of a license
 bars use of the PA compact to get a privilege to practice in another
 state.
- The PA Compact requires participating States to share "significant investigative information" with the Compact and other participating states. Rules providing more specifics about the obligation to share information have not yet been established. At a minimum there would be a tension between the PA Compact law and some of the provisions on "legally protected health care" enacted with Acts 14 and 15 of 2023. At worst, there would be a significant conflict between the PA Compact Law and those provisions.
- The PA Compact law provides for the automatic invalidation of a privilege to practice when a PA loses the "qualifying license" the PA used to obtain privileges in other States. A PA who lost their license for providing legally protected health care would automatically lose their privilege to practice in Vermont. That would conflict with 26 V.S.A. § 1354(d) (as amended by Act 15 of 2023), which prohibits professional disciplinary action based solely on providing or assisting in the provision of legally protected health care.

After discussion of those concerns, the Board was asked if any Member wanted to propose a change in the Board's position of opposition to joining the PA Interstate Licensure Compact. No Member asked to change the Board's position or to further discuss the issue.
