Umuntu ari mu Mugambi wo Kugorora Abashoferi Badafise Ubushobozi Bukwiye (Impaired Driver Rehabilitation Program (IDRP)) ashobora gusaba isubirwamwo ry'ingingo y'umugenduzi wa IDRP canke Umuganga wa IDRP, ariko abitavye ibi ntibashobora kujuririra ikintu icyo ari cyo cyose kigize IDRP gikubiye mu Mategeko y'Ubuyobozi bwa IDRP (harimo ikiringo ntarengwa C'amasomo n'ibyumweru byo kwivuzza).

Umuyobozi wa IDRP canke uwagenywe arasuzuma ubujurire n'ibikoresho cyangwa ivyandiko vyose bijanye, akaganira ku cifuzo n'umugenduzi wa IDRP, agasuzum ayandi makuru afadika yabonetse, kandi akabaza umuyobozi wa seruvise ishinzwe ivuriro rya DSU kugira ngo bahitemwo niba bokomezwe gukurikiza ivura nkuko vyasabwe.

Abo vyega bafise iminsi 60 kuba ku musi nyawo wo kubimenyeshwa kugira bunguruzwe. Kwunguruza bizokwemezwa n'ikete ryanditswe mu minsi 5 uharuye ku kirangamisi - kandi iryo rishobora kuba n'inyishu y'ukwo kwunguruza. IDRP Ifise imisi 90 yo ku kirangaminsi kugira itange inyishu kuri ukwo kwunguruza.

niba uwo vyega atemera ingingo y'Umurongozi wa IDRP, arashobora kwunguruza bicye mu nyandiko akandikira Umurongozi w'Ishami rya DSU mu misi 60 yo ku kirangaminsi utanguriye ku musi Umurongozi wa IDRP asohoreye ingingo. Umurongozi w'Ishami rya DSU afise imisi 90 kugira abe yatanze inyishu y'ukwo kwunguruza.

## Appeal Process

### Appeal Process

An IDRП participant may appeal the decision of the IDRП Evaluator or IDRП Clinician, however participants cannot appeal any component of the IDRП that is included in the IDRП Administrative Rule (including the minimum number of sessions and weeks for treatment).

Participants may submit the appeal via mail (280 State Drive NOB 2 North Waterbury, VT 05671-8340), fax (1-866-272-7989), or email ([AHS.VDHIDRP@vermont.gov](mailto:AHS.VDHIDRP@vermont.gov)) or seek review of the decision in Superior Court pursuant to Rule 75 of the Vermont Rules of Civil Procedure. The appeal must include:

- Participant name
- Participant date of birth
- DMV License number
- IDRП Education component location
- IDRП Evaluator name
- IDRП Clinician name
- Description of incident or reason for appeal
- Release of Confidential Information to speak with the participant's IDRП Clinician, IDRП Clinical Evaluator, and/or other person or organization that the participant determines would be applicable to the appeal.

The IDRП Director or designee will review the appeal and any accompanying materials or documents, discuss the request with the IDRП Evaluator, review any other pertinent information obtained, and consult the DSU Clinical Services Director to decide whether to uphold the treatment recommendation.

Participants have 60 days from the pertinent issue to file an appeal. Appeals will be acknowledged in writing within 5 calendar days—this may also be a response to the appeal. IDRП has 90 calendar days to address the appeal.

If the participant disagrees with the IDRП Director decision, they may appeal in writing to the DSU Division Director within 60 calendar days from the IDRП Director decision. The DSU Division Director has 90 calendar days to address the appeal.

If the participant disagrees with the DSU Division Director, the Criminal Division of the Superior Court (in accordance with 23 VSA § 1209(e)) will make a determination.
