## **BACKGROUND OF COLLABORATIVE DEVELOPMENT**

- Catalyzed by release of Governor Scott's 10-Point Public Safety Enhancement and Violence Prevention Action Plan in August 2022
- Focus groups and summits hosted across the specific communities (Bennington, Springfield, Brattleboro and St. Johnsbury)
- Public health, public safety and other cross sector collaborations are the core tenets of these community initiatives
- Substance use disorder is a critical element involved in the challenges our communities face, in addition to mental illness and co-occurring conditions and broader violent crime challenges - addressing these impacts as a collective is the most proactive approach
- Each of our communities is unique, and the projects are at different stages of development, but are all committed to continuing to move towards progress and better outcomes for our residents and communities by continuing to invest in this multi-sector partnership work
- Situation Table trainings with Cordata have been provided to these communities (through one-time DPS funding)
- Overarching need identified is coordinator capacity in each of these jurisdictions to assist with continuing momentum and sustainability
- This need has been expressed to the Department of Public Safety who have advised that there are no available funds to support

# FUNDING REQUEST SUMMARY ACROSS COMMUNITIES

# **CONSORTIUM COMMUNITIES & FUNDING USAGE**

- Applicant communities are Springfield, Bennington, Brattleboro, St. Johnsbury and Central Vermont
- Addiction is a driving force of chaos impacting communities across Vermont
- These communities are working together to seek funding as they have this overarching need to support the continuation of the work that was born of the the PSET summits
- It is critical to fund coordination efforts across these five communities to ensure the work continues to progress in support of the collective impact of the cross-sector work
- There is currently not another funding mechanism for this work
- Part of the efforts of the coordinators will be to work with their community to identity other future funding opportunities and resources beyond the one year of requested opioid settlement funds - having dedicated staff to support this will be critical
- Communities are at different stages of the development and work, but share many common goals and activities
- Coordinators will provide support for ongoing facilitation and coordination, based on the needs of their communities
  - Administrative and logistic support
  - Partner coordination and engagement
  - Community outreach and event support
  - Grant research

# CONSORTIUM COORDINATOR

### RATIONALE AND PURPOSE

The Consortium Coordinator will work across all participating jurisdictions to:

- Provide Expertise and Support: Offer guidance, technical assistance, and coordination across collective initiatives and their respective
  coordinators and administrative staff
- Foster Communication and Collaboration: Facilitate information sharing among partner sites across the state to highlight successes, address challenges, and strengthen ongoing work This can support the possibility of this work and groups developing into a think-tank model
- Coordinate with the Crime Research Group: Serve as a liaison to ensure accurate and consistent data collection and information sharing to support the evaluability assessment and related data measures
- **Support Reporting and Documentation:** Assist the Grantee in meeting reporting requirements and in developing regular updates and summary briefs reflecting progress across the five participating communities

### **Compensation:**

Funds will be used to engage a contractor at a professional hourly rate of \$100 per hour, for up to five hours per week, to perform the duties described above

**Note:** This role is intended to supplement—not replace or duplicate—the efforts of the existing consultants working with the Department of Public Safety's Public Safety Enhancement Team

### Rationale:

The three original communities have moved beyond the short-term consultant model that initially supported them and now require more consistent, long-term coordination. Adding a Consortium Coordinator will provide them with sustained support, strengthen communication, and create additional opportunities for collaboration beyond regular Consortium meetings.

# **SPRINGFIELD**

SPRINGFIELD PROJECT ACTION, INC.

## WHAT THE COLLABORATION IS AND WHO IS INVOLVED

- Springfield Project ACTION
- Formed in 2015, in response to increased violence and substance use related challenges
- Hiatus from 2018-2023 (some groups still met during this time and is where the Supportive Outreach Project post overdose outreach work came from)
- In January 2023 there was renewed interest from partners to re-energize Project ACTION
- The opportunity to relaunch in partnership with the State's PSET work through community Summit was beneficial
- The Project ACTION Board of Directors provides leadership for this work and includes representatives from public safety, public health, housing, town government, economic development, recovery, restorative justice and corrections
- More than 120 individuals have regular engagement in some way with Project ACTION from the weekly meetings, Situation Table, monthly partner meetings, and committees
- Some current key focus of Project ACTION have been to increase safety, decrease the
  impacts of substance use disorder on individuals and the community, enhance partnerships
  between community service organizations, create greater efficiencies with systems and
  services, provide opportunities for youth engagement

### **UTILIZATION OF FUNDS**

- Funds will support staffing for a part-time coordinator (20 hours per week) to help continue to build and strengthen Project ACTION
- Activities will include
  - Creating and documenting the process of Project ACTION
  - Assisting with planning, scheduling, and coordinating monthly meetings
  - Supporting the Board of Directors' monthly meeting
  - O Support, note-taking, and sharing updates from current and future subcommittees
  - Support the Situation Table and related Community Table, held weekly,
  - Conduct outreach to other partners to engage then in Project ACTION
  - Participating in community events, organizing volunteers, and helping to prioritize tasks.
  - Work with Project ACTION and its Board on fundraising and grant opportunities to seek sustainability of this position or to expand it
- Project ACTION has sought out other funding opportunities
  - o \$100,000 from Bureau of Justice Assistance COSSUP funding was awarded in January, and then rescinded due to the closure of COSSUP by the Federal Administration

### **Mission**

To work collaboratively with community stakeholders to mitigate the impact of crime on the community, impact substance misuse, support residents in treatment and recovery, and work towards the overall betterment of the community.

### **Vision**

Project ACTION is dedicated to utilizing community stakeholders to share information and identify necessary action steps to achieve the organizational objectives.

- Regular updates on: Data Accountability, Situation Table, Outreach Coordination, Community Building, Safety Advocacy, and Funding Opportunities

## **UTILIZATION OF FUNDS**

- Requesting capacity for group organizing and facilitation
- Without this support, the collaboration is not sustainable because putting together meeting agendas, doing background research, nudging participants, facilitating the meetings, and providing notes would not get done as smoothly or consistently

- High rates of poverty and drug addiction have led to a strong need for collaboration in Brattleboro
- Help us keep the momentum going on connecting people with resources and organizing our public safety and public health response to be efficient and effective

## One Brattleboro

The One Brattleboro leadership team is implementing and overseeing strategies related to community building, mental health/substance use, and care coordination for community members facing the highest level of complex needs.

In 2023, Brattleboro was identified by Governor Scott's Public Safety Enhancement Team as having higher-than-average rates of violent and drug-related crime, according to a prescribed set of law enforcement call data.

Ret. Lt. James Baker, a consultant with the Governor's Office, led discussions to examine the data, engage partners, and determine the next steps in addressing both the drivers (poverty, isolation, mental health) and downstream impacts (crime rate, opioid overdose, suicide).

Following a summit in Brattleboro in April 2024, One Brattleboro was formed. One Brattleboro is a public-private coalition that meets regularly to identify and address gaps or needs in public health and safety, as well as its impacts on the Town of Brattleboro.

### VISION

Brattleboro is a healthy and resilient community providing a high quality of life for its residents and a thriving local economy.

### **PURPOSE**

To develop and maintain a shared consciousness, strategic guidance, and measurable goals around protecting and improving public health, public safety, and the quality of life in Brattleboro.

- Governor Scott Visits the NEK and meets with Town Staff and Service Provider Partners on August 30, 2024.
- The Town began working with CRG in September 2024
- Situation Table Training completed June 2025
- Public Safety Task Force meets 2x monthly
- Review Police Call Data to include addresses and individuals with frequent interaction with Law Enforcement.
- Makes recommendations to bring to the Situation Table.
- Situation Table meets weekly for updates and introduction of new Situations
