youth prevention, direct treatment, first responders, and general harm reduction. The additional factual information that DSU provides shall include, but not be limited to, 1) the geographic location of the proposal and whether the proposal would provide services statewide; and 2) whether the proposed activity is already being conducted in Vermont, by whom, and where; and 3) whether there are other sources of funding, either existing or possible, for the activity proposed. Monica Hutt made a motion to amend the previous motion by adding the following highlighted text to the 2nd sentence of the motion: "The additional factual information that DSU provides shall, TO THE BEST OF THE STAFF'S ABILITY, INCLUDE but not be limited to, 1) the geographic location of the proposal and whether the proposal would provide services statewide; and 2) whether the proposed activity is already being conducted in Vermont, by whom, and where; and 3) whether there are other sources of funding, either existing or possible, for the activity proposed." The motion to amend was seconded by Ruth Hardy and the motion to amend passed unanimously. Ruth Hardy renewed her motion to adopt the previous motion as amended. Chief Burke seconded the motion. The motion as amended passed unanimously. Ruth Hardy made a motion that we have a special meeting on 11/3 for the purpose of further reviewing proposals for OSAC funding, Deb Wright seconded the motion. The motion passed unanimously. Ruth Hardy made a motion that DSU provide recovery housing and outreach workers funding information at the 11/3 meeting. Monica seconded the motion. 	Suggested the Committee read the Vermont social autopsy report to understand who is dying from drug overdoses, where they are dying and recommended interventions. He noted that abstinence centric comments were made throughout the meeting, and they may be unrealistic. He further stated that use reduction is a step towards recovery and encouraged the Committee to stay current with research.	
	Samantha Sheehan, VLCT Stated that she appreciated the hard work and deliberations of the Committee to improve transparency and have a logical process. She noted that in the beginning of the Committee, there was guidance on how to use the appropriations as these are not tax dollars, and the legislature cannot appropriate the opioid settlement funds to municipalities. She stated that the Committee has opportunities to achieve a local impact where there is a service gap and push innovation like contingency management.
