### Introduction

#### **About 802Quits**

802Quits is an evidence-based tobacco treatment program accessible by phone, online or text for Vermont residents. Program support includes over the phone cessation counseling with a trained health coach, text messaging, access to online cessation information, quit progress tracking tools and peer support, depending on enrollment type.

The quitline provides tailored protocols and incentives for priority populations. Nicotine replacement therapy (NRT) is the most used family of quit smoking medication, including patches, gum and lozenges, is available free of charge to adult enrollees 18+ and is recommended off-label with prescription for youth under 18 years old who are moderately or severely addicted to nicotine and motivated to quit.

#### **About this report**

The report provides an annual summary of 802Quits enrollment patterns and program use in fiscal year 2023 (FY2023), including year over year comparisons from 2019 – 2023 and quarterly breakdowns for 2023. The results may be used to identify trends over time, identify successes and opportunities for growth, and identify opportunities for program improvement. Only data from adult participants are included in this report. Data are summarized over the past five fiscal years, with the main focus on FY2023, which spans the timeframe of July 1, 2022 to June 30, 2023.



#### Enrollees in 802Quits services by program type




#### **Referrals from Health Care Providers**

Referrals to 802Quits can come from a variety of health care professionals, including doctors, dentists, and pharmacists.


#### Number of 802Quits referrals and conversions





#### Number of 802Quits enrollees by priority population




#### Percent of 802Quits enrollees by priority population




#### **Use of E-Cigarettes by 802Quits Enrollees**

At intake, enrollees in 802Quits services report the types of tobacco they use. From FY2019 to FY2023, the percent of enrollees aged 18-24 who use e-cigarettes increased from 33% to 88%.



Evidence from Centers for Disease Control and Prevention suggests that it may take 8–11 attempts before quitting tobacco and nicotine products permanently. In FY2023, 7.4% of enrollees in 802Quits had already enrolled at least once in the previous 4 years.


Percent of 802Quits enrollees who had already enrolled in previous years (starting with FY2019)




### **Incentives**

Starting in March 2021, the 802Quits program provides incentives for call completion for enrollees in the phone or web-phone programs from priority populations (people with Medicaid or who are uninsured, people who use menthol, people with behavioral health conditions (added in 2022), and people who are pregnant/postpartum).

#### Number of 802Quits enrollees who received an incentive by fiscal year




#### Number of 802Quits enrollees who received an incentive by type








# Percent of 802Quits enrollees who received evidence-based treatment




#### **Services Received through 802Quits**

# Percent of 802Quits website logins completed by enrollees in web program





#### Number of monthly 802Quits enrollees in FY2023




#### Percent of monthly 802Quits enrollees by program type




#### Gender distribution of 802Quits enrollees




# Educational attainment distribution of 802Quits enrollees



#### Age distribution of 802Quits enrollees




#### Racial distribution of 802Quits enrollees




#### Insurance type distribution of 802Quits enrollees




#### Percent of 802Quits enrollees who are LGBTQ+



#### Percent of 802Quits enrollees with a chronic condition







Number of monthly referrals to 802Quits from health care providers and conversions to enrollment





# Percent of 802Quits enrollees who received evidence-based treatment




#### Percent of 802Quits enrollees who received evidence-based treatment by program type




#### **Enrollees who Received Evidence-Based Treatment by Priority Population**

Percent of 802Quits enrollees with mental health conditions who received evidence-based treatment




Percent of 802Quits enrollees who are people of color who received evidence-based treatment



Percent of 802Quits enrollees who are LGBTQ+ who received evidence-based treatment




Percent of 802Quits enrollees with Medicaid or are uninsured who received evidence-based treatment




#### Number of 802Quits enrollees who received NRT



#### Percent of 802Quits enrollees who received NRT




#### Percent of 802Quits enrollees who received NRT by program type




Number of 802Quits enrollees who completed at least one counseling call



Percent of 802Quits enrollees who completed at least one counseling call




Percent of 802Quits enrollees who completed at least one counseling call by program type




#### **Nicotine Replacement Therapy (NRT)**

Average weeks of NRT received by 802Quits enrollees, excluding zero




Average weeks of NRT received by program type, excluding zero




#### **Counseling Calls**

Average counseling calls by 802Quits enrollees, excluding zero




Average counseling calls completed by program type, excluding zero




#### Number of 802Quits enrollees who received an incentive



#### Percent of 802Quits enrollees who received an incentive




Number of 802Quits enrollees who received an incentive by type




### **Demographics of Enrollees who Received an Incentive**


# Gender distribution of 802Quits enrollees who received an incentive




# Educational attainment distribution of 802Quits enrollees who received an incentive



# Age distribution of 802Quits enrollees who received an incentive




# Racial distribution of 802Quits enrollees who received an incentive


# Insurance type distribution of 802Quits enrollees who received an incentive




