## 2011 Vermont Youth Risk Behavior Survey Statewide Report

Every other year, since 1993, the Department of Health Division of Alcohol and Drug Abuse Programs and the Department of Education Student Health and Learning team sponsor the Vermont Youth Risk Behavior Survey (YRBS).

The YRBS measures the prevalence of behaviors that contribute to the leading causes of death, disease, and injury among youth. The survey provides accurate information about Vermont students and helps communities and schools increase the resiliency of young people by reducing high-risk behaviors and promoting healthy behaviors. The YRBS helps us:

- monitor trends in adolescent health and risk behaviors
- compare Vermont students with a national sample of students
- plan, evaluate, and improve community and school programs that prevent health problems and promote healthy behaviors

Participation by schools and individual students is voluntary. To protect student privacy, the questionnaire and survey process are anonymous. It is impossible to identify an individual student's responses.

We thank the principals and superintendents who chose to participate in the YRBS, the teachers and school staff who administered or in other ways supported the survey, and the students who took the time and effort to share a piece of their lives with us. We also thank the Centers for Disease Control and Prevention, Division of Adolescent and School Health for sponsoring the survey through a cooperative agreement with the Vermont Department of Education, and the CDC and Westat for technical assistance.

## Survey Changes in 2011

Before 2011, students in grades eight through twelve took the Vermont Youth Risk Behavior Survey. In 2011, we conducted two surveys:

- a high school survey of students in grades nine through twelve, and
- a middle school survey of students in grades six through eight.

All results in the 2011 high school survey report are for grades nine through twelve only. Results from earlier surveys that appear in the 2011 high school survey report will be different from those published previously. Since the middle school survey is new, there are no comparisons to previous years in the middle school survey results.

The middle school and high school surveys differed slightly. The shorter middle school survey included questions on fighting, bullying, suicidality, substance use, attitudes and perceptions about substance use, body image, physical activity, and youth assets. The high school survey included questions on these topics as well as self-reported height and weight, driving behaviors, other drug use, sexual behavior and orientation, and nutrition.

## How to Use the YRBS

The YRBS can detect changes in risk behaviors over time and identify differences among ages, grades, and genders. With these data, we can focus prevention efforts and determine whether school policies and community programs are having the intended effect on student behaviors.

Think of the YRBS as a tool for starting discussions, for educating the community, for planning and evaluating programs, and for comparing Vermont students with other students nationwide.

- Start the Conversation: Use the YRBS to begin a conversation with teens about the personal choices they make or about the health of their community. Ask them if the results accurately reflect what they see happening around them. How do they explain the results? From their perspective, what is or is not working? How would they promote healthy behaviors?
- Increase Awareness: The YRBS provides an opportunity to break through "denial" and make community members aware of the risks that their young people face. It can also dispel myths and correct misinformation about the "average teenager." The YRBS can accentuate the positive and celebrate the fact that many students are abstaining from behaviors that endanger their health and their ability to succeed.
- Plan and Evaluate Programs: The YRBS can serve as the basis of a community needs assessment. It can help identify strengths and weaknesses in communities, and can inform strategies to address those weaknesses.

Remember to Look at the Positive Side: In most cases, the majority of adolescents are NOT engaging in risky behaviors. Although most of the charts examine the prevalence of risk behaviors, please do not forget about the percentage of adolescents who are NOT engaging in these behaviors.

## About this Report

Format: The results appear in data tables, pie charts, bar graphs, and line graphs with explanatory text. In most cases, we report data by gender and grade. All results are percentages of students who responded affirmatively. The percentages in some charts may not total $100 \%$ due to rounding.

Statistical Comparisons: We note significant differences in the explanatory text. For the 2011 results, we compared the 95 percent confidence intervals separately by grade and gender to determine if the percentages were statistically different. If the confidence intervals overlapped, the percentages were not different. For comparison of 2009 results to 2011 results, we used chi-square tests. If the $p$-value from the chi-square test was less than $0.05(p<0.05)$, we determined the difference was statistically significant. For trend comparisons, we used the Centers for Disease Control and Prevention (CDC) trend analysis report. The trend analysis report uses logistic regression models that assess linear and quadratic time effects over all years of available data while controlling for gender, race/ethnicity, and grade.

Weighting: The results in this report are weighted by gender, grade, and race/ethnicity in order to compensate for differences between the sample and the population of all public students in grades six through eight (middle school survey) and grades nine through twelve (high school survey). The weighting procedure ensures that the sample is representative of this population, permitting us to draw inferences about the school-based student population based on the results of this sample.

## A Word of Caution

The YRBS represents the most complete and most recent information available about risk behaviors among Vermont students. However, the YRBS has some limitations that you should keep in mind when interpreting the results.

- Data Quality: We take numerous precautions to ensure the reliability and validity of the results. The Centers for Disease Control and Prevention (CDC) carefully designed and thoroughly tested the questionnaire. The anonymous survey encourages students to be honest and forthright. The CDC runs over 100 consistency checks on the data to exclude careless, invalid, or logically inconsistent answers. We statistically adjust, or weight, the results so that the sample accurately represents all Vermont public school students based on gender, grade, and race/ethnicity. These precautions can reduce some sources of error, but not all.
- Who's Not Included: Administrators make every effort to have all students complete the YRBS. However, students who are not at school the day of the survey are not included in the results. Additionally, students who are home schooled, attend private schools, or dropped out of school are not included. Students who attend public/private or interstate schools are included.
- Comparing Supervisory Unions/School Districts to Each Other and to the State: Participating supervisory unions and school districts receive reports of their results. It is natural to want to know how individual supervisory unions or school districts compare to the state overall or to each other. We urge caution in making such comparisons because the statewide results are weighted and the local results are not. As a result, it is possible that apparent differences, especially small differences, are due to demographic characteristics rather than to true differences in prevalence. Furthermore, small differences may not be statistically different and may simply be a function of normal sampling error.
- What, not Why: The YRBS can indicate what students are doing. It can also suggest which groups of students are more likely to engage in these behaviors. However, the survey does not answer the most important question: Why are they doing it?


## Personal Safety

Feeling safe - whether at school, in a car, or in a relationship - fosters positive adolescent development. The high school and middle school surveys included questions on fighting, bullying, seat belt use, safety at school, helmet use, and suicidality. The high school survey included additional questions on driving behaviors, dating violence, and self harm.

- Physical fighting is a marker for problem behaviors ${ }^{1}$ and is associated with serious injury. ${ }^{2,3}$ Abuse by an intimate partner and forced sex are associated with negative psychosocial outcomes, poor mental health outcomes, and other risk behaviors among both males and females. ${ }^{4,5,6}$
- Both being a bully and being victimized by bullies have been increasingly recognized as health problems for children because of their association with a range of problems, including poor psychological adjustment, ${ }^{7,8}$ poor academic achievement, ${ }^{8}$ and violent behavior. ${ }^{9}$
- Motor vehicle crash injuries are the leading cause of death among youth ages 15 to 19 in the U.S. ${ }^{10}$ Proper use of safety belts reduces the risk of fatal injury to front seat passengers by $45 \%$ and risk of moderate to critical injury by $50 \%{ }^{11}$
- Bicycle helmets are $85 \%$ to $88 \%$ effective at reducing the impact of head and brain injuries due to bicycle crashes. ${ }^{12}$ Despite this, less than one quarter of bicyclists wear helmets. ${ }^{12}$
- In 2009, alcohol use was associated with nearly four in ten motor vehicle-related fatalities nationwide and in Vermont. ${ }^{13}$ Additionally, research examining drugs other than alcohol indicates that marijuana is the most prevalent drug detected in impaired drivers, fatally injured drivers, and motor vehicle crash victims nationwide. ${ }^{14}$


## Alcohol, Tobacco, and Other Drugs

Early use of alcohol, tobacco, and other drugs is associated with myriad problems later in life. The high school and middle school surveys asked about tobacco, alcohol, marijuana, inhalant, and prescription drug use. The surveys also asked the age at which students first used alcohol, cigarettes, and marijuana. The high school survey asked additional questions on other drug use, such as heroin, methamphetamines, and hallucinogens. Both surveys asked about ease of availability of alcohol, cigarettes, and marijuana, peer disapproval of use of these substances, perceived parental disapproval of use, and the risk of harm associated with use of these substances.

- Alcohol use is a major contributing factor in about half of all homicides and sexual assaults, ${ }^{15}$ and about one-third of all motor vehicle crash fatalities. ${ }^{16}$ Heavy drinking among youth has been linked to violence, academic and job problems, suicidal behavior, trouble with law enforcement authorities, risky sexual behavior, and use of cigarettes, marijuana, cocaine, and other illegal drugs. ${ }^{17,18}$
- Tobacco use is the single most preventable cause of death in the United States, ${ }^{19}$ contributing to more than one of every five deaths. ${ }^{20}$ Cigarette smoking increases the risk of heart disease, chronic obstructive pulmonary disease, acute respiratory illness, stroke, and cancers of the lung, larynx, oral cavity, pharynx, pancreas, and cervix. ${ }^{19}$
- Marijuana use is associated with smoking-related respiratory damage, temporary short-term memory loss, decreased motivation, and psychological dependence. ${ }^{21}$ Other reactions include feelings of distrust, anxiety, or depression. ${ }^{21}$ In Vermont, more teens enter treatment with a primary diagnosis for marijuana dependence than all other illicit drugs combined. ${ }^{22}$
- Other drug use is related to suicide, early unwanted pregnancy, school failure, delinquency, and transmission of sexually transmitted diseases (STDs), including HIV infection. ${ }^{23}$
- Multi-year results from the Monitoring the Future survey indicate that the prevalence of marijuana use among youth declines as the percentage of youth expressing disapproval of marijuana increases. ${ }^{24}$ As perception of harm of using alcohol and other drugs decreases, there is a tendency for use to increase. ${ }^{24}$ Increased use is also associated with the perception that substances are readily available, regardless of whether the perception is accurate. ${ }^{24}$


## Sexual Behavior and Orientation

Experimentation with sexual behaviors and orientation often starts during adolescence. The high school survey asked about age of first sexual intercourse, frequency, sexual partners, sexual orientation, alcohol and drug use related to sexual intercourse, contraceptive use, and HIV testing. The middle school survey did not ask any questions about sex.

- Early sexual activity and having multiple sexual partners are associated with an increased risk of unwanted pregnancy, sexually transmitted diseases (STDs) including HIV infection, ${ }^{25}$ and negative effects on social and psychological development. ${ }^{26}$ Alcohol and drug use may serve as predisposing factors for initiation of sexual activity. ${ }^{27}$
- Of the nearly 19 million new cases of STDs per year in the United States, almost half are among youth ages $15-24 .{ }^{28}$ STDs may result in infertility and facilitation of HIV transmission and may have an adverse effect on pregnancy outcomes and maternal and child health. ${ }^{26}$ Besides abstinence, condom use is currently the most effective means of preventing sexual transmission of HIV and other STDs. ${ }^{29}$
- Although many lesbian, gay, bisexual, and transgender adolescents lead happy and healthy lives, others face tremendous challenges to growing up physically and mentally healthy. Compared to heterosexual youth, lesbian, gay, bisexual, and transgender youth are at higher risk for depression, tobacco, alcohol and other drug use, suicide, and unhealthy sexual behaviors. ${ }^{30}$


## Body Image

Negative feelings about weight and body image often develop in adolescence. The high school and middle school surveys included questions about weight perception and weight control. The high school survey asked for students' height and weight to calculate body mass index, and about use of artificial tanning devices.

- There are more than three times as many overweight children and adolescents in the U.S. than there were in $1980 .{ }^{31}$ Obesity in childhood and adolescence is associated with negative psychological and social consequences and adverse health outcomes, including type 2 diabetes, obstructive sleep apnea, hypertension, dyslipidemia, and metabolic syndrome. ${ }^{32}$ Overweight and obesity acquired during childhood or adolescence may persist into adulthood. ${ }^{33}$ Approximately 400,000 deaths a year in the United States are currently associated with overweight and obesity. ${ }^{20}$
- However, overemphasis on slenderness during adolescence may contribute to eating disorders such as anorexia nervosa and bulimia. ${ }^{34,35}$ Studies have shown high rates of body dissatisfaction and dieting among adolescent females, with many engaging in unhealthy weight control behaviors such as fasting and self-induced vomiting that can lead to abnormal physical and psychological development. ${ }^{36,37}$
- Indoor tanning increases risk for melanoma and non-melanoma cancers. In the U.S., the incidence of melanoma is increasing more rapidly than that of any other cancer, particularly among girls and women between the ages of 15 and 39 . Some evidence suggests that repeated UV irradiation, and the use of indoor tanning beds specifically, may have important behavioral consequences, including mood changes, pain, and physical dependency. ${ }^{38}$


## Nutrition and Physical Activity

Nutritious eating and physical activity are two cornerstones of healthy adolescent development. The high school and middle school surveys asked about breakfast consumption, physical activity, physical education classes, and television, computer, and video game use. The high school survey also asked about consumption of fruits, vegetables, soda, and sugar-sweetened beverages.

- Fruits and vegetables are good sources of complex carbohydrates, vitamins, minerals, and other substances that are important for good health. Dietary patterns with higher intakes of fruits and vegetables are associated with a variety of health benefits, including a decreased risk for some types of cancer. ${ }^{39-43}$
- In recent years, soft drink consumption has significantly increased among children and adolescents. Consumption of sugarsweetened drinks, including soft drinks, appears to be associated with an increased risk for being overweight in children. ${ }^{44-45}$
- Regular physical activity builds and maintains healthy bones and muscles, controls weight, builds lean muscle, reduces fat, reduces feelings of depression and anxiety. It also decreases the risk of dying prematurely, dying of heart disease, and developing diabetes, colon cancer, and high blood pressure. ${ }^{46}$ The U.S. Department of Health and Human Services recommends that young people ages $6-17$ participate in at least 60 minutes of physical activity every day. ${ }^{46}$
- By 12th grade, more than half of female students in the U.S. do not participate in vigorous physical activity regularly. School physical education classes can increase adolescent participation in physical activity and help adolescents develop the knowledge, attitudes, and skills they need to engage in lifelong physical activity. ${ }^{47-50}$
- Television viewing is the principal sedentary leisure time behavior in the U.S. Studies have shown that television viewing in young people is related to obesity ${ }^{51}$ and violent or aggressive behavior. ${ }^{52-54}$ Using the computer for fun and playing video games have become increasingly common sedentary leisure time activities among young people as well.


## Measures of Youth Assets

Adolescent achievement requires sources of positive influence. The high school and middle school surveys asked about school and community connectivity as well as parental conversations about school. The high school survey asked additional questions about volunteerism and grades earned in school.

- Above-average school performance is one of many developmental assets, or factors promoting positive development. Studies have shown that students who get higher grades in school are less likely to use cigarettes, alcohol, or marijuana, and are more likely to postpone sexual intercourse. ${ }^{55}$
- One of the strongest predictors of students' success in school is the extent to which their parents stay involved with their schoolwork. ${ }^{56}$ A national study of adolescent health found that youth who reported a "connectedness" to their parents/family and school were the least likely to engage in risky behaviors. ${ }^{57}$ Parental expectations regarding school achievement were also associated with lower levels of risk behaviors. ${ }^{57}$
- Research shows that involvement in constructive, supervised extracurricular activities is associated with reduced likelihood of involvement in risky behaviors such as school failure, drug use, and delinquency. ${ }^{58}$ In addition, evidence is emerging that students who participate in such activities are also more likely to engage in other "thriving" behaviors. ${ }^{59}$
- Youth are not simply objects of adult efforts to modify their behaviors. Rather, if given the opportunities, they can make significant contributions to their families, schools, and communities. Adolescents, especially, need to exercise decisionmaking power in as many settings as is practical, so that they can develop into competent adults. Schools are a natural setting for youth to share in decisions that affect their lives.

## 2011 Vermont High School Youth Risk Behavior Survey

In February and March 2011, 22,723 students at 66 high schools took the 2011 Vermont High School Youth Risk Behavior Survey. Any school that included grades nine through twelve, including public/private, interstate, and technical schools, could participate in the high school survey. Students completed a self-administered 108-item questionnaire. Survey procedures protected the privacy of students by allowing for anonymous and voluntary participation.

This report presents the results from the representative statewide sample. The Centers for Disease Control and Prevention (CDC) chose 25 schools to comprise this sample. Any school that included grades nine through twelve, including public/private and interstate schools, was eligible for the sample. Technical centers were not eligible for the sample. The CDC chose the high school sample and middle school samples independently.

The high school sample included 8,654 students. The school response rate was $96 \%$, the student response rate was $80 \%$, and the overall response rate was $77 \%$ ( $96 \% \times 80 \%=77 \%$ ).

The results in this report are weighted by gender, grade, and race/ethnicity to compensate for differences between the sample and the population of all students in grades nine through twelve in Vermont. The weighting procedure ensures that the sample is representative of this population, permitting us to draw inferences about the school-based student population.

All results in the 2011 high school survey report are for grades nine through twelve only. Rates for earlier years will be different from those published previously.

## Physical Fighting

- One in four students (23\%) reported being in at least one physical fight in the past 12 months.
- Males were significantly more likely to be in a physical fight than females. There were no differences by grade.
- Physical fighting has decreased significantly since 1993, but has remained steady since 2005.

## Safety at School

- In the past 30 days, $4 \%$ of students did not go to school because they felt they would be unsafe at school or on their way to or from school. There were no differences by grade or gender.
- One in ten students (9\%) carried a weapon to school in the past 30 days. Males were significantly more likely to report this behavior than females.
- In the past 12 months, $9 \%$ of students were in a physical fight and 6\% were threatened or injured with a weapon on school property. Males were significantly more likely to report fighting on school property than females. There were no differences by grade.

Bicycle Helmet Use

- Three-quarters of all students reported riding a bicycle.
- Among bicycle riders, 53\% reported that they rarely or never wore a bicycle helmet. There were no differences in helmet use by grade or gender.
- From 2009 to 2011, the percent of bicycle riders who rarely or never wore a helmet declined significantly.
- The percent of bicycle riders reporting rarely or never wearing helmets has decreased significantly since 1993.

## Seat Belt Use

- Overall, 85\% of students reported always or almost always wearing a seat belt when riding in a car driven by someone else. There were no differences in seat belt use by grade or gender.
- The percent of students who rarely or never wear a seat belt has decreased significantly since 1993 but remains unchanged since 2003.

## Riding with a Drinking Driver

- One in five students (21\%) reported riding with a driver who had been drinking in the past 30 days. There were no differences by grade or gender.
- Riding with a driver who had been drinking has decreased significantly since 1995 but remains flat since 2003.

## Driving Under the Influence of Alcohol

- Overall, 7\% of students reported driving after drinking in the past 30 days.
- Males were significantly more likely than females to drive after drinking, as were students in 11th and 12th grades compared to those in 9th or 10th grade.
- Drinking and driving has decreased significantly since 1995, but remains unchanged since 2003.

- One in four students (25\%) rode in a car or other vehicle in the past 30 days with someone who was using marijuana.

## Driving Under the Influence of Marijuana

- Of all students, 13\% reported driving after smoking marijuana in the past 30 days.
- Males were significantly more likely than females to drive under the influence of marijuana, as were students in 11th and 12th grades compared to those in 9th or 10th grades.
- Driving after marijuana use remains unchanged since 2001.

## Abusive Behavior

- Overall, 7\% of students were hit, slapped, or physically hurt by a boyfriend or girlfriend during the past year. Males were significantly more likely than females to report being hit or slapped, as were students in 12th grade compared to those in 9th grade.
- Of all students, 6\% have ever been physically forced to have sexual intercourse when they did not want to. Females were significantly more likely than males to report being forced to have sex. There were no significant differences by grade.

## Bullying

- In the past 30 days, $17 \%$ of students were bullied. Females were significantly more likely than males to have been bullied. Students in 9th or 10th grade were significantly more likely to be bullied than 12th grade students.
- In the past 30 days, $\mathbf{1 7 \%}$ of students bullied someone else. Males were significantly more likely than females to be bullies. There were no differences by grade.
- In the past 12 months, $15 \%$ of students were bullied electronically. Females were significantly more likely than males to have been electronically bullied, as were students in 9th grade compared to those in 12th grade.

For the purposes of the Vermont YRBS, bullying was described as occurring when, on many occasions, a student or group of students say or do unpleasant things to another student to make fun of, tease, embarrass, or scare him/her, or purposefully exclude him/her. Bullying can occur before, during, or after the school day; on school property; on a school bus; or at a schoolsponsored activity. It is not bullying when two students of about the same strength and power argue or fight, or when teasing is done in a friendly way.

Electronic bullying includes through e-mail, chat rooms, instant messaging, Web sites, or texting.

## Self-Harm

- Overall, $13 \%$ of students reported hurting themselves without wanting to die, such as by cutting or burning on purpose, in the past 12 months.
- Females were significantly more likely to report purposeful harm than males. There were no differences by grade.

## Suicide

- In the past 12 months, 19\% of all students felt sad or hopeless almost every day for at least two weeks, $8 \%$ made a suicide plan, and $4 \%$ attempted suicide.
- Females were significantly more likely than males to feel sad or hopeless, but other measures were not significantly different by gender. There were no significant differences by grade for any behavior
- The percent of students who made a plan about how they would attempt suicide has declined significantly since 1993.
- Reported suicide attempts also declined significantly from $9 \%$ in 1993 to 4\% in 2011.

## Lifetime Alcohol Use

- Overall, 60\% of students reported ever drinking alcohol. This rate is significantly lower than 2009.
- In 2011, lifetime alcohol use increased significantly with each grade. There were no significant differences by gender.
- Compared to 2009, all students except those in 12th grade were significantly less likely to report ever drinking in 2011.
- Lifetime alcohol use has declined significantly since 1993.

## Alcohol Use in the Past 30 Days

- One-third of students (35\%) drank alcohol in the past 30 days.
- Students in 11th and 12th grade were significantly more likely to drink than 9th or 10th grade students, and 10th grade students were significantly more likely to drink than 9th grade students. There was no difference by gender.
- Compared to 2009, females and students in 9th and 10th grades were significantly less likely to report drinking in 2011. There was no change in the overall rate or among males or older students
- Alcohol use in the past 30 days has declined significantly since 1993.

## Binge Alcohol Use

- One out of five students (21\%) reported binge drinking, or having five or more drinks of alcohol in a row, in the past 30 days.
- Males were significantly more likely than females to report binge drinking.
- Students in 11th and 12th grades were significantly more likely to binge than 9th or 10th grade students, and 10th grade students were significantly more likely to binge than those in 9th grade.
- Binge drinking has declined significantly since 1993.

## Alcohol Use Before Age 13

- Overall, 15\% of students reported drinking alcohol before age 13. This rate is significantly lower than 2009.
- In 2011, females were significantly less likely to report drinking before age 13 than males. There were no significant differences by grade.
- Compared to 2009, males, females, and 9th grade students were significantly less likely to report drinking before age 13 in 2011.
- Alcohol use before age 13 has declined significantly since 1993.

## Alcohol Use

- In the past 30 days, $\mathbf{1 3 \%}$ of students drank on three to nine days, $4 \%$ drank on 10 or more days, and $8 \%$ reported binging on three or more days. Only 3\% of students drank alcohol on school property in the past 30 days.
- Males were significantly more likely to report frequent binge drinking than females. There were no other differences by gender.
- Students in 11th and 12th grades were significantly more likely to drink on three to nine of the past 30 days or to binge frequently than 9th or 10th grade students. Students in 10th grade were significantly more likely to drink on three to nine of the past 30 days or to binge frequently than 9th grade students.

## Types of Alcohol Consumed by Drinkers

- Liquor is the alcoholic beverage usually consumed by nearly half (48\%) of students who drink.
- Males were significantly more likely to drink beer, and females were significantly more likely to drink wine or other alcoholic beverages. There were no differences in liquor consumption by gender.
- Students in 12th grade were significantly more likely to report drinking beer than those in other grades, and 9th grade students were more likely to report drinking wine than those in other grades. Other differences were not significant.

## Source of Alcohol Consumed by Drinkers

- Nearly half (49\%) of students who drank in the past 30 days reported their usual source of alcohol as "someone gave it to me."
- Females were significantly more likely to report that someone gave alcohol to them. Males were significantly more likely to report purchasing it.
- Obtaining alcohol from home decreased significantly with each increase in grade. Additionally, 9th grade students were significantly less likely to give someone money to buy them alcohol, and 12th grade students were significantly more likely to purchase alcohol.

## Lifetime Cigarette Use

- Overall, 24\% of students reported ever having smoked a whole cigarette. This estimate is significantly lower than 2009.
- In 2011, 9th grade students were less likely than 12th grade students to report lifetime cigarette use. There were no significant differences by gender.
- All students except those in 11th or 12th grades were significantly less likely to report ever smoking in 2011 compared to 2009.
- Lifetime cigarette use has declined significantly since 1993.

## Cigarette Use

- Of all students, $13 \%$ reported smoking at least once during the past 30 days. This estimate is significantly lower than 2009.
- In 2011, students in 11th and 12th grades were more likely to smoke than 9th grade students. There were no significant differences by gender
- Compared to 2009, all students except those in 12th grade were significantly less likely to smoke in the past 30 days.
- Cigarette use has declined significantly since 1993.

## Cigarette Use Before Age 13

- Overall, 7\% of students reported smoking a whole cigarette before age 13. This estimate is significantly lower than 2009. All students were significantly less likely to report smoking before age 13.
- In 2011, there were no differences by grade or gender.
- Smoking before age 13 has declined significantly since 1993.

## Cigarette Use

- In 2011, 5\% of all students smoked on 20 or more of the past 30 days. This rate is significantly lower than 2009.

- Only $1 \%$ of all students smoked 10 or more cigarettes or more than a pack on days smoked in the past 30 days.

## Usual Source of Cigarettes among Smokers

- Among students who smoked in the past 30 days, 19\% purchased cigarettes, 28\% gave someone money to buy cigarettes for them, and 41\% got them from someone else.
- The category "someone else" includes: borrowed (or bummed) them; person 18 or older gave them to me; took them from a store or family member.
- Females are more likely to report getting cigarettes from someone else than males. Older students are more likely to report purchasing, and less likely to report getting the cigarettes from someone else, than younger students.
- This question is new in 2011

## Quit Attempts among Smokers

- Among students who reported smoking in the past 30 days, $44 \%$ tried to quit in the past 12 months.
- There were no significant differences by grade or gender.
- This question is new in 2011.



## Other Tobacco Use

- Overall, 7\% of students reported using chewing tobacco, snuff, or dip during the past 30 days. Males were significantly more likely than females, and 12th graders were significantly more likely than 9th or 10th graders, to use smokeless tobacco.
- Of all students, $\mathbf{1 3 \%}$ smoked cigars, cigarillos, or little cigars in the past 30 days. Males were significantly more likely than females to smoke cigars, as were students in 11th and 12th grades compared to younger students.
- One in ten students (9\%) has ever used snus. Males were significantly more likely than females to use snus. Students in 12th grade were significantly more likely to use snus than those in 9th or 10th grade.

## Awareness of Students' Smoking

The survey asked, "Out of 100 Vermont high school students, how many do you think smoke cigarettes?"

- Of all students, $61 \%$ think that less than one quarter of students smoke. Of those, $22 \%$ think that 15 or fewer students smoke and $39 \%$ think that up to one quarter of students smoke.
- Of all students, $6 \%$ of students think that 56 to 75 students smoke and 5\% think that more than three quarters of students smoke.
- Three in ten (28\%) think that between one quarter and one half of students smoke.
- The percent of students who think 56 or more out of 100 students smoke declined significantly from 2009 to 2011.

## Exposure to Cigarette Smoke

- Four in ten students (41\%) were in the same room with someone who was smoking cigarettes during the past seven days, while $31 \%$ were in the same car with someone who was smoking.

- Both rates are significantly lower than in 2009.

## Discussions about Smoking

- Four in ten students (41\%) were asked if they smoked by a health professional in the past 12 months. Students in 11th and 12th grades were significantly more likely to be asked about smoking by a health professional than those in 9th grade. There were no differences by gender.
- One out of three students (34\%) discussed the dangers of tobacco use with parents or guardians in the past 12 months. Students in 9th and 10th grades were significantly more likely to discuss tobacco use with their parents than older students. There were no differences by gender.
- These questions are new in 2011.

## Lifetime Marijuana Use

- Overall, 39\% of students have ever used marijuana.
- In 2011, males were significantly more likely to report lifetime marijuana use than females. Students in 11th and 12th grades were significantly more likely to report lifetime marijuana use than those in 9th or 10th grades, and 10th grade students were significantly more likely to report lifetime marijuana use than 9th grade students.
- Compared to 2009, females were significantly less likely to report ever using marijuana in 2011. There were no significant changes by grade.

## Marijuana Use in the Past 30 Days

- One in four students (24\%) smoked marijuana one or more times in the past 30 days.
- Males were significantly more likely to use marijuana than females.
- Students in 9th grade were significantly less likely to use marijuana in the past 30 days than those in 10th, 11th, or 12th grades.

## Marijuana Use Before Age 13

- Overall, 6\% of students smoked marijuana before age 13. This estimate is significantly lower than 2009.
- In 2011, males were more likely to report using marijuana before age 13 than females. There were no significant differences by grade.
- Compared to 2009, females were significantly less likely to report using marijuana before 13 in 2011. Other differences were not significant.

## Marijuana Use

- In the past $\mathbf{3 0}$ days, $\mathbf{6 \%}$ of all students used marijuana three to nine times and 11\% used 10 or more times.

- Students in 12th grade were significantly more likely than those in 9th grade to use marijuana three or more times. Other rates were not significantly different.

## Prescription Drug Use

- In 2011, 14\% of students reported ever taking a prescription pain reliever or stimulant not prescribed to them. This estimate is significantly lower than 2009.
- Students in 9th grade were less likely to report prescription drug misuse than students in 11th or 12th grades. There were no differences by gender.

## Other Drug Use

- Less than 5\% of students used cocaine in the past 30 days or have ever used heroin or methamphetamines. About one in ten students has ever used hallucinogens or inhalants.
- Almost two in ten students (18\%) were offered, sold, or given an illegal drug at school in the past 12 months.
- Males were significantly more likely than females to report all of these behaviors except inhalant use, where there was no difference by gender.
- Students in 9th grade were less likely to use hallucinogens than older students. Other rates were not significantly different by grade.

## Parental Disapproval of Alcohol, Cigarette, and Marijuana Drug Use

- The majority of students think their parents would think it is wrong or very wrong for them to use cigarettes, alcohol, or marijuana.
- Females were significantly more likely than males to report parental disapproval.
- Perceived parental disapproval of alcohol use decreased significantly with each grade.
- Students in 12th grade were significantly less likely to report parental disapproval of cigarette use than students in all other grades, while students in 9th grade were significantly more likely to report parental disapproval of marijuana use than students in all other grades.

## Disapproval of Peer Alcohol, Cigarette, and Marijuana Use

- Students are more likely to think it is wrong or very wrong for their peers to smoke cigarettes than drink alcohol or smoke marijuana.
- Females were significantly more likely than males to disapprove of peers' cigarette or marijuana use. There were no differences in disapproval of alcohol use.
- Disapproval of peers' alcohol use decreased significantly with each grade.
- Students in 9th and 10th grade were more likely to disapprove of their peers smoking cigarettes or marijuana than 11th or 12th grade students.

## Perceived Harm of Alcohol, Cigarette, and Marijuana Use

- Students were more likely to think that people their age greatly risk harming themselves by smoking cigarettes than by drinking alcohol or smoking marijuana.
- Females were significantly more likely to perceive harm to people their age from cigarettes, alcohol, or marijuana use than males.
- Students in 9th or 10th grade were significantly more likely to perceive harm from having five or more drinks once or twice each weekend than 12th grade students, and were significantly more likely to perceive harm from smoking marijuana regularly than 11th or 12th grade students.
- There were no differences in perception of harm of cigarette use by grade.

## Perceived Availability of Alcohol, Cigarettes, and Marijuana

- The percent of students who think that cigarettes are easy to obtain declined significantly from 2009 to 2011. Other measures showed no significant differences. Females and students in 9th and 10th grades were significantly less likely to perceive that cigarettes are easy to get in 2011 compared to 2009 .
- In 2011, males were significantly more likely than females to perceive that cigarettes are easy to get. Other measures were not significantly different by gender.
- Perceived availability of cigarettes increases significantly with each grade.
- Students in 9th or 10th grade were significantly less likely to perceive alcohol is easy to obtain than older students, while students in 9th grade were significantly less likely to perceive that marijuana is easy to get compared to those in the other three grades.

- Four in ten students (41\%) have ever had sex.
- The percent of students who reported that they ever had sex increased significantly with each grade. There were no differences by gender.

## Sexual Behavior

- One-third (32\%) of all students had sex in the past three months. The percent of students who reported that they had sex in the past three months increases significantly with each grade. There were no differences by gender.
- One in four (23\%) sexually active students used alcohol or drugs prior to sex in the past three months. Females were significantly less likely than males to report this behavior. There were no differences by grade.
- Two-thirds (63\%) of sexually active students used condoms during their most recent sexual experience. There were no differences in condom use by grade or gender.

## Contraceptive Use

- Condoms are the most commonly used contraceptive, followed by prescription birth control.
- Females were significantly more likely than males to report using prescription birth control to prevent pregnancy. Males were significantly more likely to report using condoms. Other measures were not significantly different.
- Students in 9th grade were more likely to use condoms to prevent pregnancy and less likely to use prescription birth control than 11th or 12th grade students.

## Sexual Orientation

## 2011 Vermont Middle School Youth Risk Behavior Survey

In February and March 2011, 13,431 students at 111 middle schools took the 2011 Vermont Middle School Youth Risk Behavior Survey. Any school that included grades six through eight, including public/private and interstate schools, could participate in the middle school survey. Students attending schools that terminated at 6th grade (for example, K-6 schools) were not included. Students completed a self-administered 71-item questionnaire. Survey procedures protected the privacy of students by allowing for anonymous and voluntary participation.

This report contains the results from the representative statewide sample. The Centers for Disease Control and Prevention chose 25 schools to comprise this sample. Any school that included grades six through eight, including public/private and interstate schools, was eligible for the sample. Schools that terminated at 6th grade were not eligible. The CDC chose the high school sample and middle school samples independently.

The sample included 3,278 students. The school response rate was $100 \%$, the student response rate was $88 \%$, and the overall response rate was $88 \%$ ( $100 \% \times 88 \%=88 \%$ ).

The results in this report are weighted by gender, grade, and race/ethnicity to compensate for differences between the sample and the population of all students in grades six through eight in Vermont. The weighting procedure ensures that the sample is representative of this population, permitting us to draw inferences about the school-based student population based on the results of this sample.

## Among Smokers

- Of students who smoked in the past 30 days, $27 \%$ gave someone money to buy cigarettes for them, $44 \%$ got them from someone else, and $30 \%$ got them some other way.
- Not enough students purchased cigarettes to report this group.
- The category "someone else" includes: borrowed (or bummed) them; person 18 or older gave them to me; took them from a store or family member.
- Of smokers, 50\% tried quitting in the past 12 months.

## Other Tobacco Use

- Overall, 2\% of students reported using chewing tobacco, snuff, or dip during the past 30 days. Males were significantly more likely than females to use smokeless tobacco. There were no differences by grade
- Of all students, 2\% smoked cigars, cigarillos, or little cigars in the past 30 days. Males were significantly more likely than females, and 8th graders were significantly more likely than 6th and 7th graders, to smoke cigars.
- Overall, $4 \%$ of students have ever used snus. There were no differences by grade or gender.

## Awareness of Students' Smoking

The survey asked, "Out of 100 Vermont high school students, how many do you think smoke cigarettes?"

- Over half (51\%) of all students think that less than one quarter of students smoke. Of those, $20 \%$ think that 15 or fewer students smoke and $31 \%$ think that up to one quarter of students smoke.
- Overall, $15 \%$ think that more than half of students smoke. Of those, $7 \%$ think that 56 to 75 students smoke and $7 \%$ think that more than three quarters of students smoke.
- Two in ten (22\%) think that between one quarter and one half of students smoke.

## Exposure to Cigarette Smoke

- Overall, 37\% of students were in the same room with someone who was smoking cigarettes during the past seven days and $29 \%$ were in same car with someone who was smoking.
- There were no differences by gender or grade.

## Discussions about Smoking

- Overall, 20\% of students were asked if they smoked by a health professional in the past 12 months. Students in 8th grade were significantly more likely to report talking to a health professional about smoking. There were no differences by gender.

## Lifetime Marijuana Use

- Overall, 8\% of students have ever used marijuana.
- Marijuana use increased significantly with each grade. There were no differences by gender.

## Marijuana Use

- Only 1\% of students reported using marijuana before age 11.
- Overall, $5 \%$ of students smoked marijuana in the past 30 days.
- Students in 8th grade were significantly more likely to use marijuana in the past 30 days than students in 6th or 7th grades. There were no differences by gender


## Other Drug Use

- Of all students, 7\% reported ever using inhalants and 4\% reported ever misusing prescription drugs.
- Students in 8th grade were significantly more likely to have ever used inhalants than those in 6th grade, and were significantly more likely to have ever misused a prescription drug than those in 6th or 7th grade. There were no differences by gender.

## Parental Disapproval of Alcohol, Cigarette, and Marijuana Use

- Students are highly likely to perceive that their parents think it is wrong or very wrong for them to use cigarettes, alcohol, or marijuana.
- Students in 8th grade were less likely to think that their parents would disapprove if they used marijuana than those in 6th or 7th grades. There were no differences by gender.

## Peer Disapproval of Alcohol, Cigarette, and Marijuana Use

- A majority of students think it would be wrong or very wrong for someone their age to use cigarettes, alcohol, or marijuana.
- The percent of students who reported that they disapprove of peer alcohol use decreased significantly with each grade.

- Students in 8th grade were significantly less likely to disapprove of their peers smoking cigarettes or marijuana.
- There were no differences by gender.


## Perceived Harmfulness of Alcohol, Cigarette, and Marijuana Use

- Students were more likely to perceive that people their age greatly risk harming themselves by smoking a pack of cigarettes daily or marijuana regularly, than by having five or more drinks of alcohol once or twice each weekend.
- Students in 8th grade were significantly less likely to perceive great risk of harm from having five or more drinks of alcohol once or twice each weekend or smoking marijuana regularly those in 6th and 7th grades. There were no differences in perceived risk of harm of cigarette use by grade.
- There were no differences by gender.


## Perceived Availability of Alcohol, Cigarette, and Marijuana Use

- Four in ten students (40\%) perceive that alcohol is easy to obtain, compared to 32\% who perceive cigarettes are easy to obtain and $18 \%$ who perceive marijuana is easy to obtain.
- Students in 8th grade were significantly more likely to perceive that cigarettes, alcohol, and marijuana are easy or very easy to obtain than those in 6th and 7th grades.
- There were no differences by gender.

## Perceived Weight

- A majority of students (57\%) think that they are about the right weight. There were no differences by grade or gender.
- Of all students, $44 \%$ are trying to lose weight. Females were significantly more likely to report trying to lose weight. Males were significantly more likely to report trying to gain weight. There were no differences by grade.

## Skipping Meals

- Overall, $\mathbf{1 7 \%}$ of students reported skipping meals to lose weight or to keep from gaining weight in the past 30 days.
- Females were significantly more likely to report this behavior than males. There were no differences by grade.

## Breakfast Consumption

- Almost half of all students (46\%) ate breakfast every day in the past week.
- Females were significantly less likely to eat breakfast every day than males. There were no differences by grade.

## Physical Activity

- Three in ten students (31\%) participated in 60 minutes of physical activity every day, per the U.S. Department of Health and Human Services Guidelines.
- Females were significantly less likely to participate in daily physical activity than males. There were no differences by grade.
- Of all students, $8 \%$ reported zero days with at least 60 minutes of physical activity in the past week. There were no differences by grade or gender.

## Physical Education

- Eight in ten students (82\%) participated in physical education classes at least once a week.
- Overall, $\mathbf{1 4 \%}$ of students participated in physical education class every day during an average school week.
- There were no differences by grade or gender on either measure.

## Television on an Average School Day

- One quarter of students (26\%) watched three hours or more of TV on an average school day.
- There were no differences by grade or gender.
- Of all students, $7 \%$ of students spent five or more hours per school day watching TV on an average school day.

## Computer Use on an Average School Day

- Three in ten students (29\%) played video or computer games or used a computer for something that was not school work three or more hours per day on an average school day.
- Males were significantly more likely than females to report this behavior, as were students in 8th grade compared to 6th grade students.
- One in ten students (10\%) spent five or more hours per school day playing video or computer games or using a computer for something that was not school work.

## Internet Usage

- Overall, $43 \%$ of students went online on six or seven days in the past week for something that was not for school.
- Students in 8th grade were significantly less likely to report going online zero or one days than those in 6th or 7th grade.

- Six in ten (61\%) students agreed or strongly agreed that their teachers really care about them and give them a lot of encouragement. There were no differences by grade or gender.
