 Approval of the Minutes of the September 7, 2022 and September 21, 2022 Board Meetings:

Dr. Bernstein moved to accept the minutes of the September 7, 2022 and September 21, 2022 meetings. Dr. Sproul seconded the motion. The motion passed; opposed: none; recused: none; abstained: none.

Board Issues (Ms. McClain):

Ms. McClain informed members that the Diversity, Equity, and Inclusion AD HOC Committee will be meeting again on October 18th. She asked Dr. Hildebrant to provide an update on the Telemedicine Committee. He shared that the Committee had a second meeting and has completed review of the revised FSMB model policy and provided Mr. Herlihy guidance on adapting it to be a draft update to the Board's Telemedicine Policy. The draft will soon be ready to share with members.

Ms. McClain advised that she and Mr. Herlihy are working with a consultant on a presentation for the retreat in November.

Administrative Updates (Mr. Herlihy):

Mr. Herlihy noted that Jane Malago is now in the role of Licensing and Operations Administrator.

Mr. Herlihy shared the renewal update as of October 4th with 4,822 scheduled to go into renewal. 601 of these are through compact licensing and 4201 are regular licensing. With the additional MDs licensed since September 1, 2022, who are not included in the renewal number, the total number of MDs licensed in Vermont is approximately 5,000.

Mr. Herlihy informed members he went to Texas for the USMLE State Advisory Board meeting. He reported that after meeting with FSMB and NBME staff he continues to have confidence in the validity and security of the USMLE system, which the Board relies on for ensuring that applicants for licensure have the knowledge to practice safely and competently. He encouraged members to consider the different opportunities to get involved with USMLE on different committees and as exam question writers. The USMLE annual report was reviewed by the Advisory Board and will soon be released; it will be shared with members.

Mr. Herlihy noted he we will be attending the IMLCC meeting in Alabama on November 7th and 8th.

Presentation of Applications:

Applications for physician, physician assistant and limited temporary physician licensure were presented and acted upon as detailed in Appendix A, incorporated by reference into these minutes.

Ms. McClain called for a motion for the issuance of physician licenses and physician assistant licenses. (See Appendix A)

Dr. Hildebrant made a motion to accept all applicants for licensure as presented. Seconded by Dr. Liebow. The motion passed; opposed: none; abstained: none; recused: none.

Other Business:

Board Member Appointments- Mr. Herlihy informed members that there is another
opening for a Public Member on the Central Committee because Maureen Bogosian
submitted her resignation. Recruitment efforts are underway. The opening was
discussed with the DEI AD HOC Committee. The opening has been posted on the
website of an association made up of BIPOC professionals. Members were asked to
think about candidates for the opening and refer potential applicants to him for
additional information about the Board and the application process.

Mr. Herlihy then updated members on the status of reappointments. There is a new staff person in the Boards & Commissions Office, and she has worked hard to get overdue reappointments processed. A backlog had built up during the COVID-19 state of emergency when much of the staff was diverted to work focused on COVID-19 response. When the reappointment certificates were received, there was a surprise in that the terms anticipated to expire on December 31, 2023, instead had an expiration of February 28, 2023. Although up to now appointments have begun on January 1 and ended on December 31, it had been discovered that Board members should have terms that begin and end in February because Board appointments are subject to a law

pertaining to appointments that are subject to confirmation by the Senate. The appointments could not be extended out to February 2024 because that would make the appointments longer than five years. It was noted that the law provides for members to continue to serve until replaced, so despite the February 28, 2023 expiration dates, the members affected may continue to serve so long as replacements have not been appointed.
